PURCHASING

- Orders may be placed by:

- All orders will be confirmed by customer service in the same manner they were issued. If your order is not confirmed within 24 hours (M-F) please contact us.
- Purchase Orders are allowed
- Drop ship orders are accepted

PAYMENT/BILLING

- Visa, MasterCard, American Express and Discover Card are accepted.
- Net 30 terms subject to credit approval.
- Invoices are emailed unless requested to be mailed.

RESALE CERTIFICATE

- All dealers are required to submit a copy of their resale certificate.

SHIPPING AND HANDLING

- All orders are shipped UPS or FedEx ground, paid by customer. You may provide your own billing number if you choose.
- If large orders are to be shipped LTL, buyer must provide freight information or billing number.
- International shipment arrangements, other than UPS, FedEx and USPS must be made by buyer.
- For international shipments, any taxes or duties are responsibility of buyer.

PACKAGING

- All packages are shipped with your PO on shipping label. Customer PO can also be added.
- Packing lists provided on first box of shipment (invoices mailed or emailed separately).
- If you prefer to provide your own packing list it must be emailed with PO
- Orders are packed to minimize shipping costs where ever possible.
- All individual products are UPC labeled, as are case lot quantities.

ORDER MINIMUMS

- Must order in case packs of 12. Minimum order 1 case.
- Exceptions for specially marked items (*) on price list.
- Quantity price breaks noted on price sheet—must still stay in case packs of 12.

RETURNS

- Returns accepted on current merchandise in saleable packaging, only with prior approval from PrePak Products.
- All returns must have RMA #. Contact Sheila Moore (ext 101) for more info.
- Restocking fee 10% of product valuation will apply. Dealer responsible for all return freight charges.
- For defective merchandise please contact PrePak for replacements and RMA number.
